

28 governments in the Netherlands since 1945




Only 1 minority government: Rutte/Verhagen (Rutte I) 14 October 2010 - 23 April 2012




Minority goverment Rutte/Verhagen (Rutte I) (14 October 2010 – 23 April 2012)

Rutte I (Rutte+Verhagen / support Wilders) 14 October 2010 – 23 April 2012 VVD + CDA / support by PVV




Balkenende IV (Balkenende+Bos+Rouvoet) 22 February 2007 – 20 February 2010 (CDA + PvdA + CU)

Drafting the budget 2011 by minority cabinet: Budget Day (September 2010) demissionary (since 20-2-2010) cabinet Balkenende IV cuts € 3,2 billion.

Changing the budget 2011 by new cabinet (Rutte I): coalition agreement (October 2010) \rightarrow extra budget cuts \in 18 billion.

Amendments on budget 2011 by legislative (House of Representatives: elected 9-6-2010): 17 amendments, reallocating € 0,139 billion.

Drafting the budget 2012 by minority cabinet (Rutte I): Budget Day (September 2011): implementation of the coalition agreement (October 2010)

Amending the initial budget by legislative: 25 amendments, reallocating \in 0,079 billion.

Drafting the budget 2013 by minority cabinet Rutt I : including "Spring Deal" in June 2012 by legislative \rightarrow Budget Day (September 2012) package of reforms and budget cuts of \in 12,4 billion.

Changing the budget by new cabinet (Rutte II): coalition agreement (November 2011) \rightarrow changing the budget FY 2013: cuts \in 16 billion.

Amendments by legislative (elected 12-9-2012): 25 amendments, reallocating \in 0,356 billion.

Accountability Day in May 2012 (Audit FY 2011): debate influenced by cabinet crisis (23-4-2012) and new elections (12-9-2012).

Accountability Day in May 2013 (Audit FY 2012): a-typical year because of cabinet crisis and new elections (like in 2010): focus in the debate in May 2013 probably on monitoring effects of the succesive severe budget cuts.



Conclusions

- Major reallocations of the state budget are realized by political fractions in the House of Representatives after elections in the phase of creating a new coalition agreement.
- Amending the budget reallocates annualy relatively small portions of the budget. The legislative <u>has</u> the power, but doesn't executes the power of the purse in the phase of annualy amending the budgeting.
- The quality of audit and evaluation is not influenced by the signature of the cabinet. The quality of the debate on audit and evaluation is influenced by the status of the cabinet (missionair or demissionary).
- The legislative, especially opposition parties, gain influence when a cabinet is demissionair. This influence was substantial because the demissionary cabinets not only had a minority in the House, but also a minority in the Senate.
